Hamilton County Ohio 2022 Annual Report

To the County and Township Officials:

Once again, I am pleased to present you with the Hamilton County Engineer's Annual Report. Each year the County Engineer provides an annual report to the County Commissioners, in compliance with Section 5543.02 of the Ohio Revised Code. This report is inclusive of the anticipated expenditures for the construction, reconstruction, resurfacing, or improvement to the public roads and bridges in Hamilton County.

The economic climate and supply chain issues that have developed over the course of the last two and a half years following the COVID pandemic have created some unique challenges in the road and bridge infrastructure field, and the Hamilton County Engineer's Office is no exception. The rising costs of equipment, materials and fuel are slowly eroding the already tight revenue. I am happy to report that despite this, the overall status of the roads and bridges throughout Hamilton County is very strong and that is thanks in large part to the efforts of all the employees associated with this office. Hamilton County is extremely fortunate to have knowledgeable staff, skilled operators and employees dedicated to improving the infrastructure within this great county.

On the upside, last year, the County/City team was successful in obtaining substantial grant funding through the Bipartisan Infrastructure Law to complete the funding package for the replacement of the Western Hills Viaduct. Additionally, funding was obtained by the State of Ohio and Commonwealth of Kentucky to move the Brent Spence Bridge project forward. These two projects total about Four Billion Dollars' worth of transportation infrastructure improvements that will be taking place in the county in the next ten years.

The intersection of East Miami River Road and Harrison Avenue was widened to accommodate left-turn lanes at all four legs of the intersection, as well as the addition of a traffic signal. Following full-depth repairs to the pavement subgrade, East Miami River Road was resurfaced, as was the section of Harrison Avenue in the vicinity of the widening.

The project's scope included milling three inches of asphalt, full and partial depth pavement repairs, along with the removal and replacement of deteriorated curbs. The project was completed by resurfacing with three inches of asphalt.

Two areas along Cliff Road are slipping and need stabilization.

The project will involve reconstruction of the embankment / shoulder in two areas. The project's scope includes the construction of 30-inch diameter drilled pier walls to stabilize the embankment, accompanied by full depth reconstruction of the pavement and subgrade. Additionally, the guardrail will be replaced as part of the construction.

State Road to a point approximately 0.15 miles east of Five Mile Road.

The project will involve the stabilization of two landslides within the project limits. At the first site, a concrete pier wall measuring 230-feet in length will be constructed to stabilize the roadway embankment. At the second site, a failed section of T-wall will be reconstructed with gravity block wall panels reinforced with concrete grade beams. The pavement at each landslide site will be reconstructed with full depth asphalt. The remainder of the pavement within the project limits will be resurfaced with a 3-inch friction course of asphalt.

The project provides resurfacing on Sheed Road – Blue Rock Road to Gaines (westernmost intersection); Hanley Road – Sheed Road to Weiss Road; Gaines Road – Sheed Road to Saddleridge. Pavement conditions exhibit several types of deterioration including rutting and shoving; failure or road base and subgrade; alligator cracking, and potholes.

Remediation to include full and partial depth pavement repairs as required; milling of 3 inches of asphalt, construction and reconstruction of curb repair as required, and the resurfacing with 3 inches of asphalt.

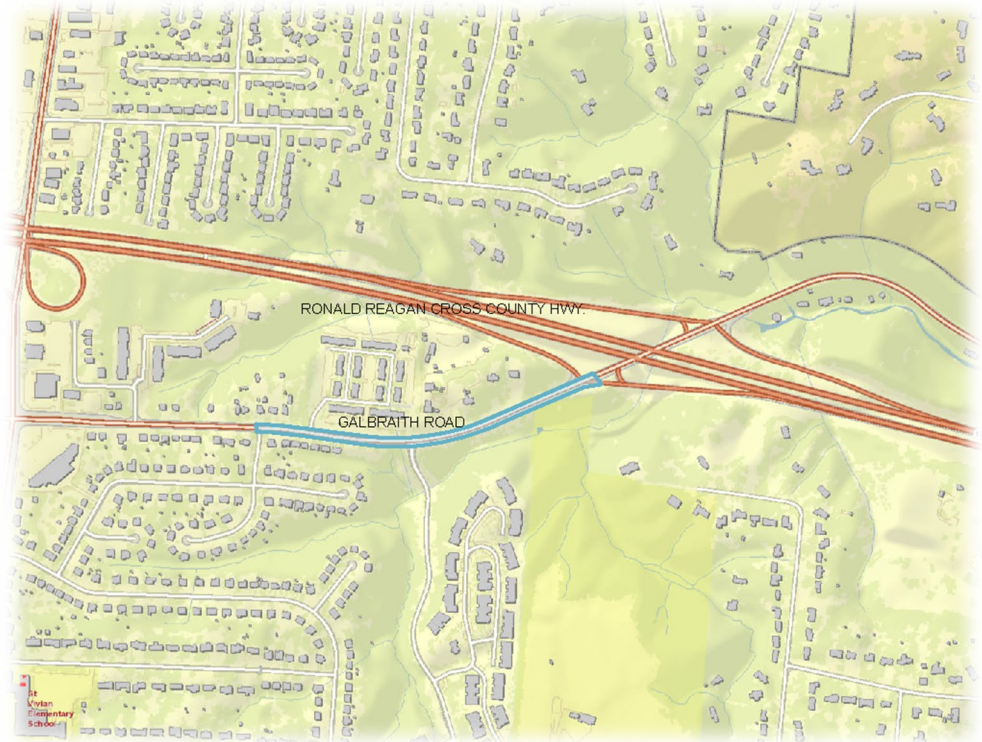

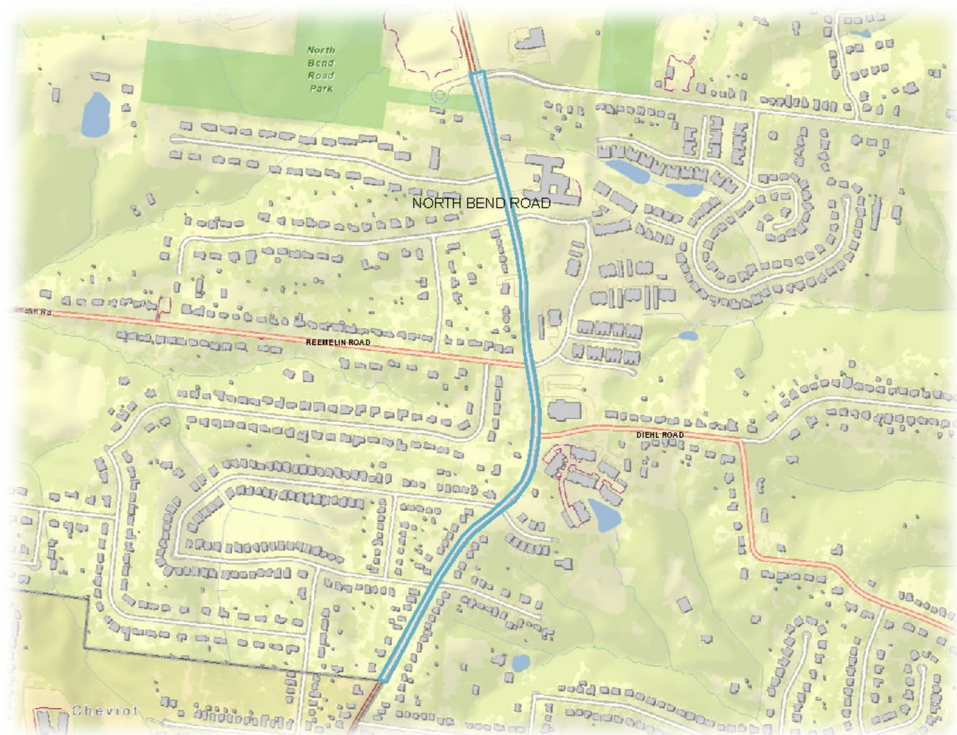

The project encompasses the section of North Bend Road between Kleman Road and the Cheviot Corporation Line near the Westwood Northern Boulevard (approximately .70 mile)

The project scope includes construction of left turn lanes on Reemelin and Diehl roads at the intersections with North Bend Road. The project will include full and partial depth pavement and curb repair as required and will provide a 3-inch-thick asphalt resurfacing. Approximately 600 feet of this resurfacing (located in the curve between Diehl Road and Hader Avenue) will receive a friction course of asphalt. Additionally, the construction of new sidewalk is included in this project.

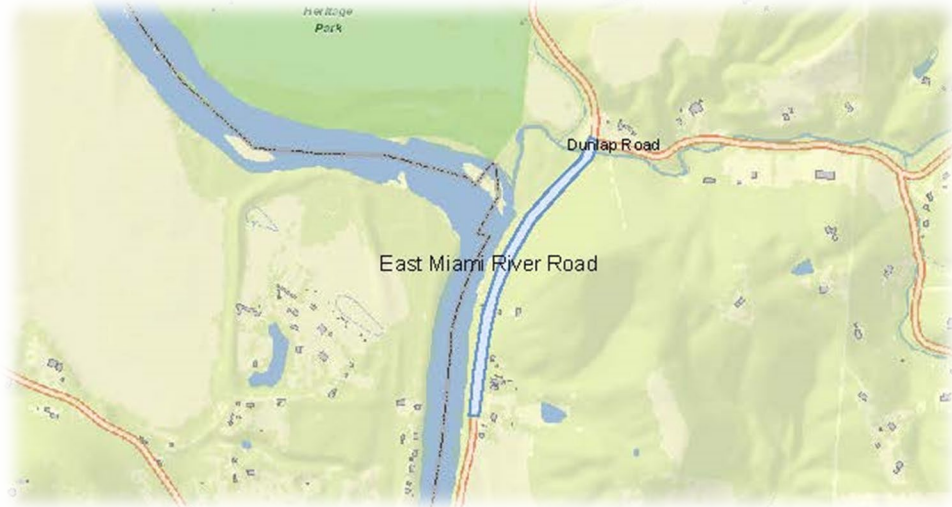

 - Forty catch basins
 - 1,150 feet of 24-inch diameter pipe
 - 2,210 feet of Type 6 concrete curb

- Reconstruction of the pavement within the landslide impacted area.
- Resurfacing of the pavement outside of the landslide impacted area which is to include:

- Full and partial depth repairs as required.
- Mill 3-inches of asphalt.
- Construction and reconstruction of curbs as required.
- Resurfacing with 3-inches of asphalt.
- Replacement of guardrail.

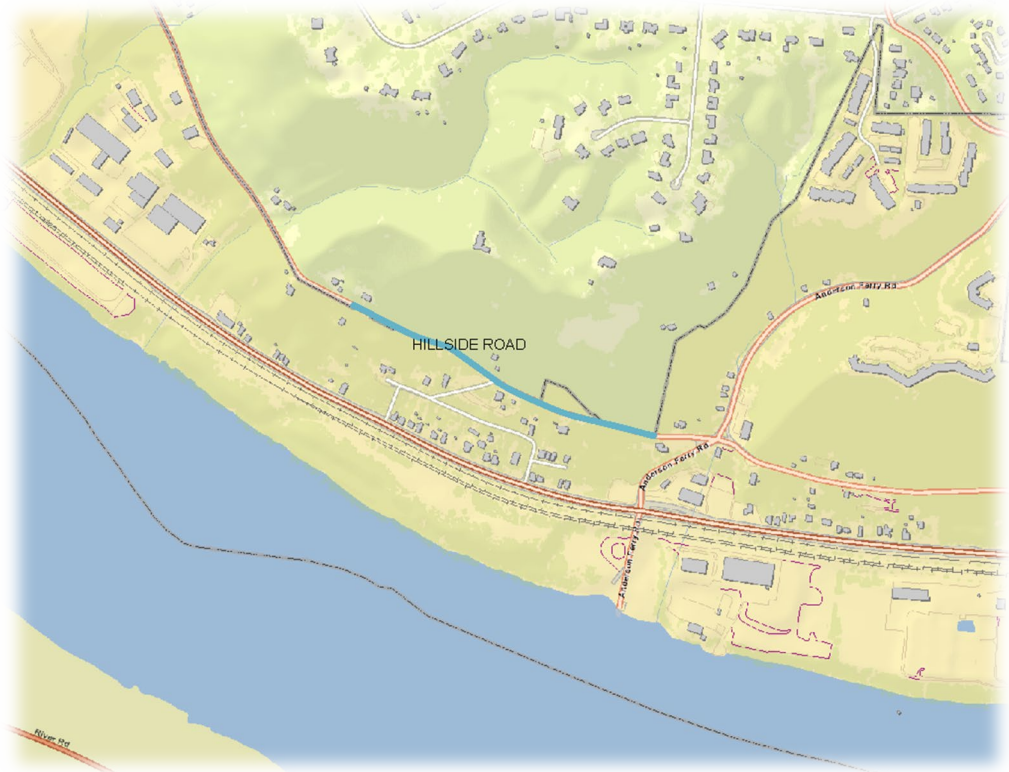

The GIS Department also manage the data used in the mapping for the Office of the Hamilton County Engineer's 832 Geodetic Control Points which provide horizontal and vertical survey control along with the coordinates of the Section Corners that have been located within the county.
