DISCUSSION:

CFA Members **G. McFarlin, P. Brehm, B. Cull, and K. Hardman** inquired about and discussed the City's intentions to redirect its transient occupancy tax residual funds from the CFA waterfall distribution subject to the existing Seventh Supplement. The various Authority members inquired the current amount and use of the waterfall earmark to be redirected by the City and its impact to the waterfall's obligations and commitments to the operations, maintenance, and repairs of the DECC.

To varying degrees, these Authority members did not necessarily object to the City's request to redirect its transient occupancy tax residual funds but were concerned about equitable release of City and County residual payments from Seventh Supplement: \$250,000 and \$1.0M respectively; sufficient guarantee City will operate and maintain the DECC to standards to which the

CFA is obligated; and to some extent, the northern facilities are not harmed by redirected waterfall dollars.

City and County staff, including legal representatives, attempted to address the CFA Authority members' concerns and answer all of their questions or comments.

As a result of the presentation and subsequ	uent dialogue
with staff representatives, the CFA Board pas	ssed with one
dissenting vote the following motion, moved	
and seconded by	:

To demonstrate CFA's agreement in principle to the City's voluntary use of its transient occupancy tax residual funds to provide funding for infrastructure improvements associated with the FC Cincinnati stadium in the West End neighborhood and to acknowledge the City and County will strive to reach mutually agreed upon language for an 8th supplement to be subsequently approved by this Authority.
