The Coronavirus Disease 2019 (COVID-19) is being described by the U.S Department of Health and Human Services Center for Disease Control as an emerging, rapidly evolving situation. Our Court has been closely monitoring the COVID-19 pandemic and the response of federal, state, and local leaders and health officials in combatting the spread of the virus. As we track this progressing health situation, we have and will continue to be proactive and take necessary measures to keep our staff and the public safe.

To mitigate health risks, hand sanitizers have been installed on both floors of our Court near the elevators. The County is increasing cleaning and disinfecting routines throughout the building especially in highly trafficked areas and on frequently touched surfaces. We encourage everyone visiting the Court to use the resources available and to follow the Hamilton County Public Health recommendations to protect yourself from illness:

- Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol. Always wash hands with soap and water if hands are visibly dirty.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.

The Court remains open as providers of essential government services. We will continue to monitor reports from government leaders and health officials as the situation unfolds and will meet with Hamilton County officials to discuss steps we can take to further minimize the risk of spreading infectious disease.

If you have upcoming business at the Hamilton County Court of Domestic Relations, stay alert for changing conditions based on the scope of the outbreak and the severity of the illness. - The Judges and Magistrates have the ability to conduct some hearings over the phone or via Skype with limited ability as requested.
